Qualifying for the Accelerated Binary is simple.

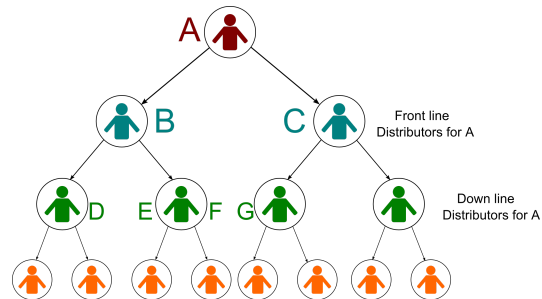
**Step 1.** Get qualified by personally being active and using our products at 40 BV OR referring a minimum 160 BV of product to active customers per month.

### Earn Commissions From Team Effort

After the first order is paid out in Fast Start, each additional order is paid in the Dual Team Structure using 100% of the BV value.

**The Dual Team Pays**  
**\$10 Per Cycle of: 40bv : 40bv**



You "Cycle" each time the computer matches 40 BV on one leg to 40 BV on the other with unlimited potential. All Dual Team Commissions are subject to the Independent Representative reaching the requirements.

## Purchase or Production Requirements and Limitations

either through the optional convenience order (monthly auto delivery option) and/or by the retail sales of product through their personally replicated Websites provided by Level Up. This requirement is to be maintained within the qualifying month, on a month to month basis.

## Scheduled Payout For Bonuses

Commissions and Bonuses are paid out weekly, Commissions are calculated on the sales of the previous week. Level Up, Inc's Compensation plan is one of the most aggressive in the industry. To sustain this aggressive compensation, Level Up, Inc reserves the right to adjust payout if total monthly payout in the matrix exceeds 65% of generated BV. Adjustment is only applied in this scenario and will resume regular schedule when the payout is equal to or less than 65%

## Rank Advancement

Rank advancements achieved in any given month will be paid out according to that rank in the following month and continue each month so long as the LEVEL UP IR is qualified.
